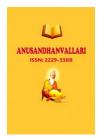

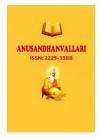

## Research Methodology:

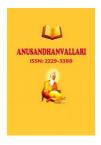
This paper adapts a mixed subliminal approach of both qualitative and quantitative research:

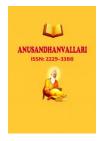
- Decolonization took a significant force when a evident growth in sovereign states was witnessed following the wars.
