Research Objectives

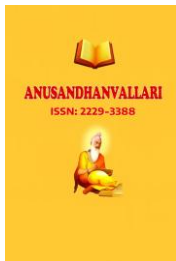
1. This paper examines how gender norms shape and limit women's autonomy.

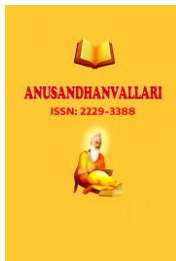

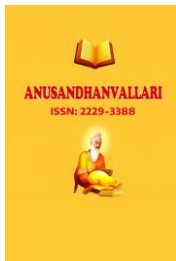

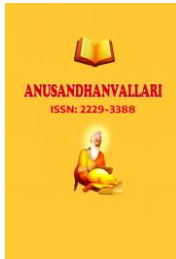
