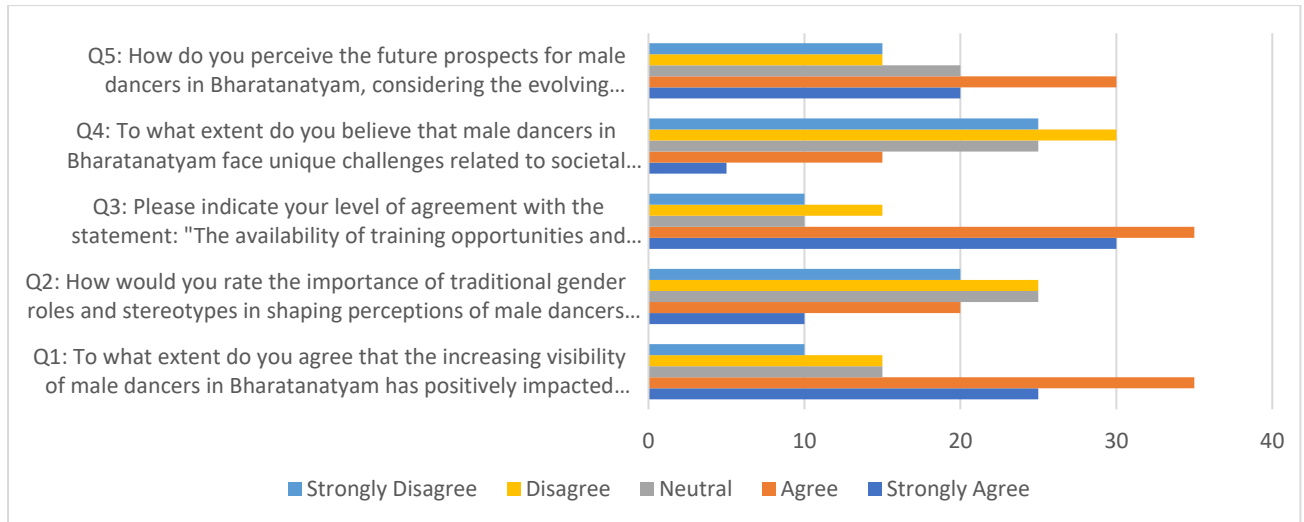
## 3.0 Research Methodology

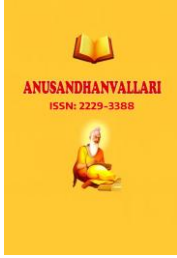
