The Prabhát Samgiita is a musical gharana that represents a groundbreaking time in the history of melodies, distinguished by its remarkable qualities. The name "prabháta," derived from the Sanskrit word "dawn," symbolizes the fundamental nature of this gharana, serving as an indication of the commencement of a groundbreaking era in music. Founded on September 14, 1982 in Deoghar, Bihar, by the esteemed composer Shrii Prabhat Ranjan Sarkar, this music school is known for its exceptional commitment to artistic expression. Despite his busy schedule as the head of Ananda Marga, Sarkar remarkably composed a total of 5,018 songs by October 21, 1990. Moreover, the translation of one of the songs from Prabhat Sangeet, as mentioned in the Sarkar book, is as follows:

"Regardless of my thoughts,

*I have considered thoroughly
Everything I have done, I have done for the benefit of everyone.
The aroma emitted by the Champaka flower
I have disseminated from one residence to another,
Between residences,
Throughout successive lifetimes,
My beat will compel people to dance,
My perseverance will ensure the safety of others.
Upon the harmonious melody, I am transported to a distant place.
And restored the continuous stream of divine happiness." (AnandMurthi, 2021)*

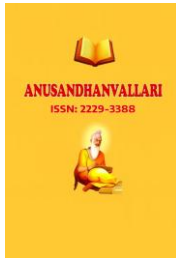
